## 1. APOLOGIES FOR ABSENCE.

No apologies for absence were received. Cllr Jenkins was absent from the meeting.

Resolved: Noted.

### 2. DECLARATIONS OF INTEREST.

Resolved: That no declarations of interest were made.

# 3. MINUTES.

Resolved: That the Minutes of the meeting held on 9 February 2023 were approved as a correct record and signed by the Chairman.

A further discussion regarding planning application 22/03028/OUT took place. This planning application has been approved, however, the Parish Council objected to the temporary use of green space to the front of the 1829 building on Liverpool Road for car parking and would like to be kept informed of the expected timelines regarding the reinstatement of the green space.

Resolved: The Parish Council will write to the CoCH Women's and Children's project developers to ask for information regarding the restoration of the green space. Also, to be kept informed of the proposed residents' meetings.
